**QUALIFICATIONS FOR RETAIL MEMBERSHIP**

All individuals, co-partnerships and corporations owning and regularly engaged in the operation of one or more retail lumber and building materials yards in Arkansas, Kansas, Missouri or Oklahoma shall be eligible for active retail membership in this Association.

A retail lumberyard is defined as one which maintains an adequate and permanent plant, properly equipped for service to the public, with office, storage yard and warehouse, kept open during usual business hours, with such handling facilities and sales as are commensurate with the nature of the business, and which carries a well-assorted stock of lumber or building materials (for the purpose of selling at retail, in small and large quantities, and not primarily for its owners' consumption), sufficient to supply the ordinary needs of customers within its community.

**RETAIL MEMBERSHIP AGREEMENT**

The undersigned hereby applies for Retail Membership in the Mid-America Lumbermens Association. It is understood that this application shall include affiliate membership in the National Lumber and Building Material Dealers Association, Washington, D.C.
